I further consent to the above named child's participation in the Ski Club. I understand that a BRT Charter Service, Motorcoach or Minibus or Parent Volunteers in their vehicles will be providing the transportation for the above named child to and from school to Boston Mills Ski Resort, 7100 Riverview Road, Peninsula, Ohio.

In consideration of the child being allowed to participate in the St. Bernadette Ski Club, on behalf of my child and my spouse (if applicable), I hereby assume all risks in connection with the Ski Club and I further release the Diocese of Cleveland, the Bishop of the Roman Catholic Diocese of Cleveland, St. Bernadette Parish (church and school), as well as their employees, Ski Club advisors, and all volunteers from all claims, judgments, liability for any injury or damage due to the child's participation in the Ski Club, including all risks connected therewith whether foreseen or unforeseen. Furthermore, I acknowledge that it is my responsibility to provide adequate health insurance for my child.

In addition, I hereby understand that exposure to COVID-19, disease and sicknesses is an inherent risk of participation in the St. Bernadette Ski Club. I understand that the St. Bernadette Ski Club cannot eliminate the risk that my child is exposed while engaging in this activity. I and my child agree that it is our/his/her responsibility to 1) follow all instructions, signage, warnings and guidelines; 2) stay home if sick or experiencing symptoms of any sickness; 3) wear a face covering and maintain at least 6 feet physical distancing from other participants and advisors whenever possible; and 4) wash and sanitize his/her hands frequently. I hereby assume all COVID-19 risks in connection with the Ski Club and I further release the Diocese of Cleveland, the Bishop of the Roman Catholic Diocese of Cleveland, St. Bernadette Parish (church and school), as well as their employees, Ski Club advisors, and all volunteers from all claims, judgements, liability for any injury or damage due to the child's participation in the Ski Club, including all risks connected therewith whether foreseen or unforeseen.
